



La-Z-Boy Directors Declare Quarterly Dividend, Authorize Six Million Share Stock Repurchase

MONROE, Mich., Feb. 10 /PRNewswire-FirstCall/ -- Directors of La-Z-Boy Incorporated (NYSE: LZB; PCX) today declared a quarterly cash dividend on the company's common stock of \$0.10 per share, the same rate paid in the prior quarter. The current dividend is payable March 10, 2004 to shareholders of record February 27, 2004.

The directors also authorized the repurchase of up to an additional six million shares of the corporation's common stock at such times and prices deemed opportune by corporate management. The previous stock repurchase authorization, approved by the directors in August 2002, still has 1.4 million shares remaining.

With annual sales in excess of \$2 billion, La-Z-Boy Incorporated is one of the world's leading residential furniture producers and marketers. La-Z-Boy's operating units produce furniture for every room of the home and office, and the company is also a leading manufacturer of hospitality and assisted-living contract furniture and specialized health care seating.
